

# Fingerprinting Registration Instructions

Applicants who would like to be fingerprinted electronically at an IdentoGO location may visit [www.sled.sc.gov](http://www.sled.sc.gov) to begin the process.

**Step 1- Select "New CWP Application- I do not currently have a Concealed Weapons Permit (CWP)."**

**Step 2- Complete application and scheduling process.**

Carefully follow each step of the registration process, paying special attention to the forms of ID and required documentation to bring to your appointment (see page 2 of this document).

# Required Identification and Paperwork

## All Customers

Two (2) valid forms of identification are required to complete enrollment:

- South Carolina State issued Driver's License or government issued photo ID.
- Secondary ID must be one of the following: Passport, Birth Certificate, Social Security Card, Voter's Registration Card, DMV issued photo ID or a current utility bill showing applicant's name and address.

<b>Retired Law Enforcement \$0.00</b>	<ul style="list-style-type: none"> <li>• Retired SC Law Enforcement Officers exempt from training must present legal update and firearm training documentation.</li> <li>• A signed copy of SLED CWP Instructor Student Checklist (Retired Law Enforcement Officers not currently certified must complete the legal portion of CWP training only and provide proof of service through the submission of certificate showing graduation from a federal or state academy that had firearms qualification as a graduation requirement.</li> <li>• Qualified nonresident applicants must present a complete Real Property Tax Form (SLED Form R-168).</li> </ul>
<b>Active Law Enforcement \$50.00</b>	<ul style="list-style-type: none"> <li>• Active South Carolina Law Enforcement officers exempt from any training must present current legal update and firearms training documentation.</li> <li>• Active South Carolina Law Enforcement officers must present a copy of their LEO credential and/or employee badge (if employed by the South Carolina Department of Corrections).</li> <li>• Active out of state Law Enforcement Officers must complete the legal portion of CWP training and provide proof of service through the submissions of a certificate showing graduation from a federal or state academy that have firearms qualification as a graduation requirement.</li> <li>• Qualified nonresident applicants must present a complete Real Property Tax Form (SLED Form R-168).</li> </ul>
<b>Active Military \$50.00</b>	<ul style="list-style-type: none"> <li>• Military orders- if stationed in SC, you must present military orders that show a SC duty station. (No training courses required).</li> </ul>
<b>None of the Above \$50.00</b>	<ul style="list-style-type: none"> <li>• Non-US citizens must present an Alien Registration Card (Green Card) or I-94 with their admission number issued by the US Department of Homeland Security.</li> <li>• Qualified nonresidents applicants must present a completed Real Property Tax Form (SLED Form R-168).</li> <li>• A signed copy of the SLED CWP instructor/Student Checklist (CWP Training courses must have been completed within three years of filing the application).</li> </ul>
