CWP Application – Student Requirements

All CWP students must *complete* a CWP Application to process a CWP permit request. There are required forms needed with the application depending on your status. Below you will find the documents required for each status of the application.

STATUS:

New

- Checklist
- Current copy of SC DL (address must match the address on the form – mailing purposes)
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)

Disable Veteran

i *You are exempted from Firearms Training only.*

- Checklist (Legal portion only)
- Current copy of SC DL (address must match the address on the form – mailing purposes)
- Current VA letter providing the percentage rate of disability to include **Name** on the form, or copy of DV service-connected card
- Copy of DD-214 (Name and SSN must be legible)
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)

Retired/Former Military

i *Exempt from taking the Firearms Training only.*

- Checklist (Legal portion only)
- Current copy of SC DL (address must match the address on the form – mailing purposes)
- Copy of DD-214 (Name and SSN must be legible)
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)

Active Military

i You are exempted from Firearm Training and Legal Training.

- Current copy of DL
- Current SC Military Order Papers (must be within the last 4 years)
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)

Active Law Enforcement

i Legal Training and Firearms may be obtained by Agency's Training.

- Current copy of SC DL (address must match the address on the form – mailing purposes)
- Current copy of Agency issued ID Card (Current Credentials)
- Current copy of firearms and legal training (ACADIS, or in-service training)
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)

Retired Law Enforcement

- Checklist (Legal portion only)
- Current copy of SC DL (address must match the address on the form – mailing purposes)
- Copy of Current Retired Agency Credentials **and/or** Retirement system pay stub
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)

Non-Resident

- Checklist
- Current copy of DL
- Completed SC Property Tax Form **and/or** a printout of the property information by searching: Tax Assessor, County of Owned Property – **name must** be on form.
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)

Non-Citizen

i Please include your Alien # on the application.

- Checklist
- Current copy of SC DL (address must match the address on the form – mailing purposes)
- Copy of current alien card.
- 2 legible Applicant Fingerprint cards (All information must be completed on both cards)
